York Street, Mechanicsburg, PA 17055, helping ensure continued public safety and emergency response services for the community. \$171,218 – Keystone Trails Association: The funding will allow the association to retain a qualified engineer or architect to develop plans, drawings, and specifications, and to obtain necessary permits and approvals for an upgraded facility at Scott Farm. "CAEDC was proud to assist with the grant application process and celebrate the successful award of funding for these projects. Working with dedicated partners to bring tangible benefits to Cumberland County communities is central to our work" said CAEDC Economic Development Director, Greg Welker.
